Internet Service Providers: Submit the form via e-mail to "[<hostmaster@ripe.net>](mailto:hostmaster@ripe.net)." (If the ISP is not a [Local Internet Registry](#) , the form should be submitted to the upstream provider.)

Network Administrators: Send the form to the Internet Service Provider from which you received it.

Please include the Registry Identifier in the header of the message or at the top of this form. Further, any modifications to the templates may result in a delay in handling.
